The ego tells us that to meet on the level we should talk down to others or lower ourselves to be where they are. Serving the ego is mediocre, serve your highest self.

'Ego, in psychoanalytic theory, that portion of the human personality which is experienced as the "self" or "I" and is in contact with the external world through perception. It is said to be the part that remembers, evaluates, plans, and in other ways is responsive to and acts in the surrounding physical and social world.

Simply put...

...Men's egos are big. Especially over money and women. Pride is a scary thing and can be toxic. Money is the root of all evil and if it's not shared unconditionally, it's owed and that's power to some people.

...Nothing sadder than seeing a man bullied by money owed to a toxic woman. Nothing sadder than seeing a woman beaten just because she's funded by a man.

In the words of Jennifer Woo, CEO and chair of The Lane Crawford Joyce Group, Asia's largest luxury retailer, "Managing our ego's craving for fortune, fame, and influence is the prime responsibility of any leader." Interesting view. This Harvard business article by Rasmus Hougaard and Jacqueline Carter, November 06, 2018, titled "Ego Is the Enemy of Good Leadership" reads well on the subject of ego ... 'caught in the grip of the ego's craving for more power, we lose control. Ego makes us susceptible to manipulation; it narrows our field of vision; and it corrupts our behaviour, often causing us to act against our values. Our ego is like a target we carry with us. And like any target, the bigger it is, the more vulnerable it is to being hit. In this way, an inflated ego makes it easier for others to take advantage of us. Because our ego craves positive attention, it can make us susceptible to manipulation. It makes us predictable. When people know this, they can play to our ego. When we're a victim of our own need to be seen as great, we end up being led into making decisions that may be detrimental to ourselves, our people, and our organization.

An inflated ego also corrupts our behaviour. When we believe we're the sole architects of our success, we tend to be ruder, more selfish, and more likely to interrupt others. This is especially true in the face of setbacks and criticism. In this way, an inflated ego prevents us from learning from our mistakes and creates a defensive wall that makes it difficult to appreciate the rich lessons we glean from failure. Finally, an inflated ego narrows our vision. The ego always looks for information that confirms what it wants to believe. Basically, a big ego makes us have a strong confirmation bias. Because of this, we lose perspective and end up in a leadership bubble where we only see and hear what we want to. Servant leadership traits in a leader will see a more humane and consistent form of management and improvement. I believe we should look to servant leaders to govern countries.

Martin Luther King Jr. (MLKjr); January 15, 1929 – April 4, 1968) was an American Baptist minister, activist, and

political philosopher who was one of the most prominent leaders in the civil rights movement from 1955 until his assassination in 1968. A black church leader and a son of early civil rights activist and minister Martin Luther King Senior, MLKjr advanced civil rights for people of colour in the United States through the use of nonviolent resistance and nonviolent civil disobedience against Jim Crow laws and other forms of legalized discrimination.

MLKjr participated in and led marches for the right to vote, desegregation, labor rights, and other civil rights. He oversaw the 1955 Montgomery bus boycott and later became the first president of the Southern Christian Leadership Conference (SCLC). MLKjr was one of the leaders of the 1963 March on Washington, where he delivered his "I Have a Dream" speech on the steps of the Lincoln Memorial and helped organize two of the three Selma to Montgomery marches during the 1965 Selma voting rights movement. The civil rights movement achieved pivotal legislative gains in the Civil Rights Act of 1964, the Voting Rights Act of 1965, and the Fair Housing Act of 1968.

The SCLC put into practice the tactics of nonviolent protest with some success by strategically choosing the methods and places in which protests were carried out. There were several dramatic standoffs with segregationist authorities, who frequently responded violently. MLKjr was jailed several times. Federal Bureau of Investigation (FBI) director J. Edgar Hoover considered MLKjr a radical and made him an object of the FBI's COINTELPRO from 1963 forward. FBI agents investigated him for possible communist ties, spied on his personal life, and secretly recorded him.

COINTELPRO (a syllabic abbreviation derived from Counterintelligence Program) was a series of covert and illegal projects conducted between 1956 and 1971 by the United States Federal Bureau of Investigation (FBI) aimed at surveillance, infiltrating, discrediting, and disrupting American political organizations that the FBI perceived as subversive. Groups and individuals targeted by the FBI included feminist organizations, the Communist Party USA,

anti-Vietnam War organizers, activists in the civil rights and Black power movements (e.g., Martin Luther King Jr., the Nation of Islam, and the Black Panther Party), environmentalist and animal rights organizations, the American Indian Movement (AIM), Chicano and Mexican-American groups like the Brown Berets and the United Farm Workers, and independence movements (including Puerto Rican independence groups such as the Young Lords and the Puerto Rican Socialist Party).

When MLKjr was in prison, he met fellow convict John Bembry, a self-educated man he would later describe as "the first man I had ever seen command total respect ... with words". Under Bembry's influence, Malcolm developed a voracious appetite for reading.

Nelson Rolihlahla Mandela incarcerated for who served as the first president of South Africa from 1994 to 1999. Mandela spent approximately 27 years in prison for opposing South Africa's apartheid system. He refused to give up his efforts to achieve equality for all people. While incarcerated he continued to fight for his political virtues. This quote from Nelson Mandela's prison time relevant to my personal experience with police and the need I recognised which would stump out of control corruption and dire outcomes: "Now is the time for the police to act with sensitivity and restraint, to be real community police men and women who serve the population as a whole. There must be no further loss of life at this tragic time." – NELSON MANDELA (Conversations with Myself).

I can say I did a lot of reading during these police framed; government approved political imprisonment torts. That stated, I certainly did more writing than reading. Yet plenty of books and television was looked at. Listening, learning and growing through others, complimented by reading autobiographies like my own literature, war literature and author development education. Leadership of servitude

nature. You be the judge of any improvements (or not) to my authoring over the next few autobiographies. Jail, as a targeted individual due to Human Rights advocacy certainly felt like servitude at times.

There are some great stories out of oppression and detainment. Myself, a Human Rights activist, not a man nor a martyr. This incarceration nearly broke my poor little spirit and its hopes for resolution and fair trial regarding police and government criminal negligence. I had to remind myself that great things, great people have achieved much out of adversities.

Activities inspired by a desire to resist oppressive policies and unjust laws which violate the principles of Human Rights and fundamental freedoms that form the foundation of democratic government.

To watch free speech eroding at any avenue with oppression allowed to flourish in covert and obscure ways while Julian Assange was finally free from incarceration himself, surreal. Those who support oppressive police opinion and diminish our rights to freely speak the truth are just as guilty of vile and heinous atrocities as those taking the actions of injustice. The "Why was I in prison (innocent) while sex offenders and vile criminal offenders roamed free?" question and answer pounded at the forefront of my mind. Why?? because no one wanted to be responsible for failing to address sexual violence against disabled persons, sexual violence by police against minors and decades of criminal negligence in governance in general.

The Adelaide Women's Prison (AWP); a clear arm of government and freemasonry to me from admit into the institution. The torts of incarceration (both in Victoria and South Australia) eye opening. No presumptions of innocence in this hell hole of criminals. Guards bring in drugs and receiving head jobs from inmates and colleagues, more drugs in the low security yard 'than can be dealt with' - repeating loosely how a manager put it. Guards played

sports with police, commuted with prosecution and courts: nosev people prving into the lives of the unsentenced doing more bad than good as I witnessed it. Yet, no avenue for the innocent. I was innocent, I did not send the corny email read to the courts on the 15^{th of} July 2024. The email was my email yes, but the first email especially was definitely not myself. I knew I was 'set up' with SAPOL using frivolous charges to oppress reality with perception – literally 16 days before Barbwire Noose TVC launched on Channel 9. It broadcast a year after initiation in 2023 and three months after recorded and finalised April 2024. My second and third Trimester, to finish my Fashion and Sustainability Diploma in 2024 completely lost to torts based around sex crimes. I was over starting over to get so far before some government funded agenda kicked me and my brand in the guts. Over and over again.

A lot of AWP operations based on uniforms (cop wannabes, ex-cops, employment-based friendships); I certainly could not trust (police – SA Labor government) anyone around me. Fed by Chinese whispers – we all know how that ends from just a class of thirty people in primary school. A celly I had in the ROSE Units of Living Skills Unit in the prison put the prison environment best – "There is no honesty amongst thieves." Very true of AWP inmates. Jail friends they call them – most telling me they don't hang out, outside of jail which I respected the significance of.

SAPOL locking me away twice in 2024 hoping no one will care, no one will notice. It felt like a relentless game of keep the cover up rolling and make her seek the refuge of suicide. Incarcerated based on falsified intervention orders stemming from perjury regarding social media posts. No threats, no intimidation, no stalking. No case to answer. Yet the police made one up like it was an achievement. Gaslighting the media and public to obstruct justice for the disabled and myself. The use of over a million dollars on legal fee spent to protect SA Police Association misconduct was not going to be wasted on just a cover up. Time, effort and taxpayer's

funds wasted to see me locked up for a good part of 2024. Incarceration costing the taxpayer more than a year's wage on Centrelink pensions (Human Services). Desperate efforts to distort the truth compromising my life and livelihood as justice was torn from disabled persons and others incarcerated by petty harassment and set ups. Australia needed Human Rights legislated at a federal level. I needed recognition under legislation regarding whistleblowing and the desperation of petty oppressions and grabs at freedom of speech via intervention orders needed to stop – the offender(s) calling himself a victim, muddy water making it appear to be deep.

'Australia needs a national Human Rights Act to ensure that the rights of all people are protected, all of the time.' — Australian Human Rights Commission; 2023.

Australian Human Rights Commission Act 1986: It gives effect to Australia's obligations under the following: International Covenant on Civil and Political Rights (ICCPR) Convention Concerning Discrimination in Respect of Employment and Occupation (ILO 111) Convention on the Rights of Persons with Disabilities.

While incarcerated I watched National Press Club on the 3 July 2024 talking the topic 'Free + Equal: safeguarding the rights of all Australians'. Quoting Guest Speaker Professor Rosalind Croucher (President of the Australian Human Rights Commission) calling out leadership to federally legislate Human Rights in Australia - "As we leave the COVID-19 pandemic in the rear-view mirror, as we contemplate the challenges of climate change into the future, and as we consider the social justice implications of cost-of-living pressures, it is time for better protection of human rights to be a central consideration by our Parliament and our Government. If we do value fairness, if we do value dignity, if we do care about equality of opportunity in this country, then we need this foundation of human rights to be embedded and strengthened for all. The centrepiece of our

national human rights reform agenda is a national Human Rights Act including all Human Rights listed in the Universal Declaration of Human Rights (International/United Nations)."

Human Rights Matter. My time at AWP proved that. I had the right to defend myself when being targeted and victimised via the system and seedy men. The right to respond and publicly disclose such illegalities. For a more detailed account of my time at AWP 2024, read Political Prisoner #192703 Autobiography. The manuscript completely drafted from prison.



Chapter Three 'What's Been on My Mind'

DONALD TRUMP SHOT AT RALLY, ELECTED AS INCOMING PRESIDENT (REPUBLICAN) 2025.

Yep, this one has been on my mind! Everyone knows the yanks are a bit crazy – same can be said for us Australian's. But nothing beats the crazy of American politics! How hectic – Trumpet the next Kennedy! Who thought.

One must wonder was it a warning shot – the media threw this out to the wolves as a conspiracy, sadly with numerous persons in the crowd injured and even unfortunately dying, you can probably conclude the shooter was a bad shot and not giving out a subtle hint. Initially the incident was reported with media like 'The FBI continues to investigate the shooting incident at the July 13 rally in Butler, Pennsylvania, as an assassination attempt on former President Donald Trump and as potential domestic terrorism.' – Not long after, the shooter had a name and was dead. In all seriousness this is an ugly level of barbaric in

modern society, yet sends a clear message, one lunatic to another – "Don't fuck with us." Not every American out there is impressed by Trump's antics and this violent act clearly displays exactly this.

The Republican VS Democrats race was awkward and almost out of control to the point where a long-known fact seen Joe Biden step behind his Vice-President in the race (age/cognitive capacity) while a criminal conviction over a short-term known fact by a man (D.J.Trump) with questionable honesty strives forward like nothing happened. The fact that Donald John Trump (DOB14June1946) was reelected, after conviction as a publicly known perverted republican says it all about the results of witch hunting a person to be hated.

WHISTLEBLOWER PROTECTION

No surprise I've been thinking about this topic. Life. This concerns protecting people who act in the public interest when disclosing serious wrongdoing to the authorities. This wrongdoing usually relates to environmental and health issues or information relating to corruption, misconduct and maladministration in public administration. Laws protecting whistleblowers exist at both State and Commonwealth levels.

Specifically, my own public disclosures and my immunity when it comes to doing so; Public interest information may be disclosed in certain circumstances to a journalist or a member of Parliament (other than a Minister of the Crown). Where a person has previously made an appropriate disclosure to a relevant authority and has not within the specified time frame received notification that their

disclosure has been assessed, they may then disclose that information to a journalist or MP. Closed investigations holding seemingly no public disclosure terms and the Police Commissioner (and others) with discretionary powers to allow complaint public disclosure during investigations. The perjury that led to intervention orders against me and incarceration torts based on frivolous and vexatious charges shows the importance of whistleblower protection and the Public Interest Disclosure Act (PID Act).

No reliance can be placed on any document oral advocacy SAPOL provided to court regarding myself. Institutionally harassed and victimised by government departments since 2014 after reporting police misconduct to the police Ombudsman under the ICAC Act and to SAPOL Special Investigations Unit.

SA Labor Government Minister Marielle Catherine Smith (DOB30Dec1986; also known as Marielle Feuerherdt Smith) calling for a Royal Commission into SAPOL under the SA Liberal government of Steven Marshall in 2019. Seeking rule Commission after my submissions to parliament and appropriate departments about malfeasance as well as ICAC recommendations. Police investigating police the core of misconduct and criminality surrounding myself and the community failures that derive from and an assist toxic culture displaying unjust outcomes from abuse of power and process. Ignorance to illegal and poor police behaviour; despite ministers and countless whistleblowers calling for Royal Commission into SAPOL over the last decade, including myself.

As a whistleblower, reporter of governance associated crimes, I have been subject to institutional torts - harassment acknowledged by Magistrate Teresa Anderson in 2018 at the Mount Gambier Magistrates Courts and reprisal regarding

reported criminal negligence in the Disability sector. I should be protected under whistleblower laws of state and federal litigation.

It should be noted as 'on my mind' that a person who causes detriment to another on the ground, or substantially on the ground, that the other person or a third person has made or intends to make an appropriate disclosure of public interest information commits an act of victimisation.

The objects of the PID Act are— (a) to encourage and facilitate the disclosure, in the public interest, of information about substantial risks to public health or safety, or to the environment, and about corruption, misconduct and maladministration in public administration— [(i) (ii)] (b) to ensure that there is appropriate oversight of public interest disclosures about corruption, misconduct and maladministration in public administration.

RELEVANT LEGISLATION:

- (2) An act of victimisation under this Act may be dealt with— (a) as a tort; or (b) as if it were an act of victimisation under the Equal Opportunity Act 1984, but, if the victim commences proceedings in a court seeking a remedy in tort, the victim cannot subsequently lodge a complaint under the Equal Opportunity Act 1984 and, conversely, if the victim lodges a complaint under that Act, the victim cannot subsequently commence proceedings in a court seeking a remedy in tort.
- (3) If a complaint alleging an act of victimisation under this Act has been lodged with the Commissioner for Equal Opportunity and the Commissioner for Equal Opportunity is of the opinion that the subject matter of the complaint has already been adequately dealt with by a competent authority, the Commissioner for Equal Opportunity may decline to act

- on the complaint or to proceed further with action on the complaint.
- (4) In proceedings against a person seeking a remedy in tort for an act of victimisation committed by an employee or agent of the person, it is a defence to prove that the person exercised all reasonable diligence to ensure that the employee or agent would not commit an act of victimisation.
- (5) A person who personally commits an act of victimisation under this Act is guilty of an offence. Maximum penalty: \$20 000 or imprisonment for 2 years.
- (6) Proceedings for an offence against subsection (5) may only be commenced by a police officer or a person approved by either the Commissioner of Police or the Director of Public Prosecutions.
- (7) In this section— detriment includes— (a) loss or damage (including damage to reputation); or (b) injury or harm (including psychological harm); or (c) intimidation or harassment; or (d) discrimination, disadvantage or adverse treatment in relation to a person's employment; or (e) threats of reprisal. (f) For the purposes of this section, a threat of reprisal may be— (a) express or implied; or (b) conditional or unconditional, and in any proceedings dealing with an act of victimisation (including proceedings for an offence against subsection (5)) it is not necessary to prove that the person threatened actually feared that the threat would be carried out.

LEGISLATION ETRACT: 5—Immunity for appropriate disclosure of public interest information

(5) A disclosure of public interest information is made to a relevant authority if it is made to— (a) where the information relates to a public officer— (i) a person who is, in accordance with any guidelines prepared under section 14, designated as a person who is taken to be responsible for the

management or supervision of the public officer or to the relevant responsible officer; or (ii) a person who is, in fact, responsible for the management or supervision of the public officer or to the relevant responsible officer; or (b) where the information relates to a public sector agency or public sector employee— [(i) (ii) (c)] the Commissioner for Public Sector Employment; or the responsible officer for the relevant public sector agency; or where the information relates to an agency to which the Ombudsman Act 1972 applies—the Ombudsman; or (e) where the information relates to a risk to the environment—the Environment Protection Authority; or (f) where the information relates to a risk to the environment—the Environment Protection Authority; or where the information relates to an irregular and unauthorised use of public money or substantial mismanagement of public resources—the Auditor-General; or where the information relates to a risk to the environment—the Environment Protection Authority; or (g) where the information relates to the commission, or suspected commission, of any offence—a member of the police force; or (h) where the information relates to a judicial officer—the Judicial Conduct Commissioner; or (j) where the information relates to a person or a matter of a prescribed class—an authority declared by the regulations to be a relevant authority in relation to such information; or (k) a Minister of the Crown; or (1) OPI; or (m) any other prescribed person or person of a prescribed class.

The Corporations Act 2001 (Cth) also protects officers and employees of a company who disclose information of illegal practices, fraud or misappropriation of funds to company auditors. It is an offence under the Act for a person to be penalized (victimised) for such disclosures.

The Public Interest Disclosure Act 2013 (Cth) protects public officials (wider than public servants, includes defence force and others) who make prescribed disclosures. The disclosure must be made to an authorised officer or to the person's supervisor. The person disclosing the information is protected from civil and criminal liability as well as disciplinary action.

Public interest information affects the wellbeing of the community. The Act applies differently to the following two types of public interest information: 1. Environmental and health information – where there is a substantial risk to the environment or to public health and safety. 2. Public administration information – where there is potential corruption, misconduct or maladministration in public administration. Protections are provided for public officers who make an appropriate disclosure of public administration information and for all persons who make an appropriate disclosure of environmental and health information Preventing or hindering disclosure A person must not— (a) prevent another person from making an appropriate disclosure of public interest information under this Act; or (b) hinder or obstruct another person in making such a disclosure.

The PID Act is Non-derogation This Act is in addition to, and does not derogate from, any privilege, protection or immunity existing apart from this Act under which information may be disclosed without civil or criminal liability.

- 5—Immunity for appropriate disclosure of public interest information
- (1) If— (a) a person makes an appropriate disclosure of environmental and health information; or b) a public officer makes an appropriate disclosure of public administration

information, the person is not subject to any liability as a result of that disclosure. (2) This section has effect despite any duty of secrecy or confidentiality or any other restriction on disclosure (whether or not imposed by an Act) applicable to the person. (3) A person makes an appropriate disclosure of environmental and health information for the purposes of this Act if the disclosure is made to a relevant authority and the person—(a) believes on reasonable grounds that the information is true; or (b) is not in a position to form a belief on reasonable grounds about the truth of the information but believes on reasonable grounds that the information may be true and is of sufficient significance to justify its disclosure so that its truth may be investigated. (4) A public officer makes an appropriate disclosure of public administration information for the purposes of this Act if the disclosure is made to a relevant authority and the public officer reasonably suspects that the information raises a potential issue of corruption, misconduct or maladministration in public administration. (5) A disclosure of public interest information is made to a relevant authority if it is made to— (a) where the information relates to a public officer—(i) a person who is, in accordance with any guidelines prepared under section 14, designated as a person who is taken to be responsible for the management or supervision of the public officer or to the relevant responsible officer; or (ii) a person who is, in fact, responsible for the management or supervision of the public officer or to the relevant responsible officer; or (b) where the information relates to a public sector agency or public sector employee— (i) (ii) (c) the Commissioner for Public Sector Employment; or the responsible officer for the relevant public sector agency; or where the information relates to an agency to which the Ombudsman Act 1972 applies—the Ombudsman; or (d) where the information relates to a location within the area of

a particular council established under the Local Government Act 1999—a member, officer or employee of that council; or (e) where the information relates to a risk to the environment—the Environment Protection Authority; or (f) where the information relates to a risk to the environment the Environment Protection Authority: or where the information relates to an irregular and unauthorised use of public money or substantial mismanagement of public resources—the Auditor-General; or (g) where the information relates to the commission, or suspected commission, of any offence—a member of the police force; or (h) where the information relates to a judicial officer—the Judicial Conduct Commissioner; or (i) (j) where the information relates to a member of Parliament—the Presiding Officer of the House of Parliament to which the member belongs; or where the information relates to a person or a matter of a prescribed class—an authority declared by the regulations to be a relevant authority in relation to such information; or (k) a Minister of the Crown; or (1) OPI; or (m) any other prescribed person or person of a prescribed class.

Personal injuries claim VS Redress. Plus, what is an 'exgratia' payment? (Incarceration torts)

Sexually abused on duty 2001 by SAPOL Police Officer of Mount Gambier Police Station (institution) SAPOL/ICAC found officers guilty of ethical misconduct 2021/2022. – This statement alone concludes a full payment of the Redress available to victims of child sexual abuse by institutional employee.

Reported to SAPOL (K.Dalton, 2017 and K.Hammond, 2018); the sexual abuse and repeated attempt at sexual abuse

by SAPOL detectives assigned to investigate the theft of my stolen VH Commodore Holden, White, led to a life of Complex Post Traumatic Stress Disorder (CPTSD). Smoking marijuana as a treatment for the trauma the institutional abuse disrupted my attendance to university to study law and practise criminal law.

I have recurring flashbacks, and the offence was a devastating and shameful experience whilst in the special care of SAPOL.

Demonstrating extraordinary bravery in coming forward and disclosing the institutional abuse I suffered; personal injury lawyers experience exposes that it is common for survivors to suffer catastrophic trauma from such abuse which in turn effects many aspects of life. CPTSD does not deem mental instability yet gives insight to life's trajectory and the broader basis institutional abuse claim and the personal injury effects. Redress compensation didn't take enough consideration to my trauma I was legally advised when putting forward my claim against SAPOL.

INCARCERATION TORTS – Miscarriage of Justice.

An ex-gratia payment is a one-off payment which a state or territory government may choose to provide to someone affected by a wrongful conviction, on its own accord or due to a request by a party.

States and territories are able to make these discretionary payments, with their authority flowing from the 'Executive Power' provided to the government under the Constitution. Payments are made at the discretion of the territory or state Attorney General, and a decision to refuse to make a payment is not reviewable in any way, with no guidelines imposed.

"the provision of compensation for miscarriage of justice in the circumstances... may be by administrative procedures rather than pursuant to specific legal provision."

What are other schemes of compensation?

In New Zealand, a formal scale has been developed for ex gratia payments, including \$NZ150,000 for each year in custody, in addition to up to \$NZ100,000 for loss of livelihood during that period, and up to \$NZ50,000 to help re-adjust to living in the community.

Without such a scale, it is hard to determine what compensation may be provided, with determination thus branded as arbitrary and inconsistent.

"While any payment is better than none, when seeking compensation, a wrongfully convicted person shouldn't be left to the discretion of an administrative decision-maker whose determination about whether to provide compensation, and how much if so, cannot be appealed and is not determined by reference to any objective scale." commented Pettit.

The United Nations developed the International Covenant on Civil and Political Rights. Under Article 14 of the ICCPR, everyone has the right to liberty and freedom from arbitrary detention. Where this right has been violated, victims should be compensated "according to the laws of their country". In 1980, the Fraser Government agreed to ratify the ICCPR, validating it as international law.

The United Nations' own Human Rights Commission has consistently stated that these options are unsatisfactory, recommending on multiple occasions that Australia withdraw the reservation.

"In some cases, even when [exonerees] are awarded, they make sure to say that this does not set a precedent," Dioso–Villa (Dioso-Villa; Senior Lecturer in the School of

Criminology and Criminal Justice at Griffith University and a member of the Griffith Criminology Institute). Recourse can include ex gratia payments (payments made despite there being no legal obligation to do so), which are offered in a range of situations involving income loss or damage costs. In Australia, ex gratia payments for wrongful conviction are made at the sole discretion of a state's Attorney–General—a government-appointed position. Payments are often politically motivated, only granted after extensive public outrage or a Royal Commission (like in the case of Lindy Chamberlain). Decisions regarding compensation awards are rarely published and there is little transparency in the decision-making process or in the way that compensation is calculated. "We don't know what happens behind the scenes, how they reach their decisions before the awards are given or denied," explained Rachel Dioso-Villa, a senior lecturer at Griffith University in Oueensland, who published the most extensive list of Australia's wrongful convictions. – Human Rights opinion Article: When Justice Fails - Wrongful Convictions in

A quote which briefly and distinctly describes some of the emotions which overwhelmed me during wrongful conviction: "It is difficult to imagine, for a person who is otherwise generally a law-abiding citizen, a more humiliating experience or a greater shock to one's equilibrium than being forcefully deprived of one's liberty for even a relatively short period of time in circumstances which are entirely unjustified. This is all the more so where that curtailment of liberty is accompanied, as in the present case, by the detained person being handcuffed and marched through a crowd of onlookers and then incarcerated in a police paddy wagon, locked in a cell at the police station

and fingerprinted and photographed as a criminal. Not surprisingly, the whole experience must have been both humiliating and highly embarrassing."

Compensation for wrongful conviction is not only a right – a human right but it is a necessity to deter, stop and repent an action which sometimes has no compensable measure upon the suffering inflicted by this demoralising, dehumanising, destabilising and humiliatingly damaging ordeal. Lara Zarowsky, a law instructor at the University of Washington, worked with her students to advocate for legislation aimed at compensating the wrongfully convicted, successfully introducing a state-wide law in 2013. Zarowsky said: "[It is] a vehicle, really, for people in this position to be able to get some sort of nominal amount for their immeasurable pain and suffering... it also represents official

recognition that these cases can and do happen."

Chapter Five 'Sport'

Playing sports is not time wasted, but time well spent! Be serious about the sport you play; you can master the game!

'Sports, physical contests pursued for the goals and challenges they entail. Sports are part of every culture past and present, but each culture has its own definition of sports. The most useful definitions are those that clarify the relationship of sports to play, games, and contests. "Play," wrote the German theorist Carl Diem, "is purposeless activity, for its own sake, the opposite of work." Humans work because they have to; they play because they want to. Play is autotelic—that is, it has its own goals. It is voluntary and uncoerced. Recalcitrant children compelled by their parents or teachers to compete in a game of football (soccer) are not really engaged in a sport. Neither are professional athletes if their only motivation is their pay-check. In the real world, as a practical matter, motives are frequently mixed and often quite impossible to determine. Unambiguous definition is nonetheless a prerequisite to practical determinations about what is and is not an example of play.' (Source: Britannica)

Here I am going to talk a little about some significant moments in time that make, break and display the significance of sports in our society.

Cambridge University Library, the 1936 Berlin Olympic Games puts it best. 'The 1936 Olympics will mostly be remembered for the exploitation of the Games by the Third Reich in pursuit of Nazi ideology. The Olympics were a political coup for Reich Minister of Propaganda Joseph Goebbels, who ordered the removal of anti-Semitic slogans from Jewish shops, moved "undesirables" out of Berlin, toned down the racist Nazi newspaper "Der Stürmer" and organised groundbreaking TV and radio broadcasting of the Games.'

After America took their fellow black man to the Berlin Olympic Games. An unignorable point was made that the Aryan race is not superior. My favourite sporting history highlight of predominantly black men is the Dream Team, nickname given to the 1992 U.S. men's Olympic basketball team, which went undefeated in eight games at the Summer Olympics in Barcelona. It was the first U.S. men's Olympic basketball team to include professional basketball players from the NBA.

A sucker for anything aquatics – swimming, teaching swimming a prominent role of my life I cannot pass up the opportunity to mention American swimmer Michael Phelps, age 23, winning his eighth gold medal at the 2008 Olympic Games in Beijing. Breaking the record for most golds garnered at a single Games (set by another U.S. swimmer, Mark Spitz, at the 1972 Olympic Games in Munich) the feat was hailed as one of the greatest individual achievements in

sports history, and Michael Phelps was proclaimed by many the greatest Olympian of all time. Yet had it not been for extraordinary performances by Jason Lezak, Michael Phelps's teammate in two gold medal-winning relay efforts, all the hard work that brought Michael Phelps so close to achieving his Olympic dream might have been for nothing.

Sports Therapy is an aspect of healthcare that is specifically concerned with the prevention of injury and the rehabilitation of the patient back to optimum levels of functional, occupational and sports specific fitness, regardless of age and ability.

It utilises the principles of sport and exercise science incorporating physiological and pathological processes to prepare the participant for training, competition and where applicable, work.

I have used sports therapy to treat my CPTSD since go – 2001. Refusing to take a long-term pharmaceutical for something I hoped to recover from, I focused on natural treatments to my anxiety/depression. The following abstract with the objective of this study to synthesise the evidence on the effects of physical activity on symptoms of depression, anxiety and psychological distress in adult populations. An umbrella review with data sources from twelve electronic databases were searched for eligible studies published from inception to 1 January 2022.

Eligibility criteria for selecting studies involving systematic reviews with meta-analyses of randomised controlled trials designed to increase physical activity in an adult population and that assessed depression, anxiety or psychological distress were eligible. Study selection was undertaken in duplicate by two independent reviewers.

The results based on ninety-seven reviews (1039 trials and 128,119 participants) were included. Populations included healthy adults, people with mental health disorders and people with various chronic diseases. Most reviews (n=77) had a critically low.

A Measurement Tool to Assess systematic Reviews score. Physical activity had medium effects on depression (median effect size=-0.43, IQR=-0.66 to -0.27), anxiety (median effect size=-0.42, IQR=-0.66 to -0.26) and psychological distress (effect size=-0.60, 95% CI -0.78 to -0.42), compared with usual care across all populations. The largest benefits were seen in people with depression, HIV and kidney disease, in pregnant and postpartum women, and in healthy individuals. Higher intensity physical activity was associated with greater improvements in symptoms. Effectiveness of physical activity interventions diminished with longer duration interventions.

The conclusion and relevance of the study regarding the positive effects of physical exercise: Physical activity is highly beneficial for improving symptoms of depression, anxiety and distress across a wide range of adult populations, including the general population, people with diagnosed mental health disorders and people with chronic disease. Physical activity should be a mainstay approach in the management of depression, anxiety and psychological distress.

WEAPONISED PHOTOGRAPHY

Over the ages we've seen weaponised photography win elections, fuel war propaganda and even shutdown the internet with a fake AI porn version of Taylor Swift.

World War Two seen photographs used as a means of controlling both subjects and audiences. People, with a natural tendency to believe whatever is evident in an image, makes photography the perfect foundation for propaganda.

The general consensus on the matter is the weaponization of photography is a partial reflection of a modern culture and its willingness to consume and interpret imagery without analysis or concern for who might be victimized by the image. The rate at which photos and video can spread online feeds this insatiable consumption. After the tragic live double homicide of journalist Alison Parker and cameraman Adam Ward, The New York Times' Farhad Manjoo commented,

"The killings appear to have been skilfully engineered for maximum distribution, and to sow maximum dread, over Twitter, Facebook and mobile phones...[Flanagan] seems to have known, for instance, that in a nation in which tens of thousands of people are killed by firearms every year, the shooting of two people would not become international news if it was not filmed: as is commonly said online, 'Pics, or it didn't happen'."

Quoting Susan Sontag comments "Photographs of an atrocity may give rise to opposing responses. A call for peace. A cry for revenge. Or simply the bemused awareness, continually restocked by photographic information, that terrible things happen." Indeed, war photography has served a purpose of glorifying soldiers (e.g. Roger Fenton) as well as shocking nations to the horrors of war (e.g. Margaret Bourke-White, Yosuke Yamahata, etc). In the 21st century, photographs of an atrocity don't wait to give rise to opposing responses, created and distributed with an intent to harm and polarize.

Political wins due to photography influences that stand out due to AI are namely the Tyding VS McCarthy election.

The Gordon government used a picture of 'Vietnam cong flag' and the media to confuse and conflate facts during the war. An incident known as the 'Battle of the Flags' – McCarthy VS Gordon.

July 2006 seen clouds of smoke enhanced by weaponised photography – Hesbela and Israel at war and an image with

smoke added to it circulated the news from the ABC to Reuters

Joseph Stalin, Former Premier of the Soviet Union, didn't have Photoshop. This technological setback did not stop him from altering photos. Wiping the traces of his enemies from the history books. Even the famous photo of Soviet soldiers raising their flag after the Battle of Berlin was altered.

2023 seen many AI generated photographs of Donald Trump being arrested.

In 2006, my family started to full throttle disintegration after an image of my Mum was falsified to depict her kissing another man (man accused to my father of being Mick Dermody – long term best friend of Dads).

Revenge porn (countless victims including myself) - confounding issues around "ownership" of the images, revenge porn has been particularly difficult to fight with a few states legislating against the humiliating activity by introducing invasion of privacy laws. In January 2015, the Pittsburgh-based K&L Gates law firm created the Cyber Civil Rights Legal Project to aid victims of revenge porn citing copyright infringement and emotional distress.

"Generative AI's meteoric rise can be hard to grasp. In 2019, I authored the first research mapping the landscape of deepfakes and AI-generated content. A major finding was the number of deepfakes had almost doubled from 7,964 in December 2018 to 14,678 in July 2019. Contrast this to

August 2023, where one study estimated that a staggering 15.47 billion AI-generated images had been produced in just over a year. This number would be much higher today, particularly if it included AI-generated videos, voice audio and music.

The generative AI explosion was sparked by the technology becoming radically more accessible. Tools that were embryonic in leading AI research labs a few years ago are now available on thousands of user-friendly apps and services. At the same time, AI-generated content has become increasingly realistic, advancing in areas such as voice cloning and personalized avatars at an astonishing speed." (Source: World Economic Forum https://www.weforum.org/)

"The Camera Could be a Weapon": Gordon Parks on the Power of Photography - "I had chosen my camera as a tool of social consciousness. Common sense told me I had to have sufficient understanding of what was right or wrong, otherwise that camera could eventually become my own enemy." Gordon Parks may be considered a true incarnation of the American myth of a self-made man.

AI-generated content becoming increasingly realistic, advancing in areas such as voice cloning and personalized avatars at an astonishing speed gives massive avenues to sexual exploitation crimes and extortion/disruption of relationships, stability, the family nucleus as targets – subject of weaponised photography.

The supercharged dynamic of propaganda for gains these days can be more creatively used and abused. Commercial and prosocial applications, also seeing a massive growth of amateur photographers in the sector seeing short term misuse and weaponization of generative AI. Extortive AI increasing friction in relationships and families when exploiting private topics or interactions can be combatted by open communications. Good communication and reporting amateur -bad actors misuse generative AI where we can effectively intervene on this long-term, decades long plot to stay ahead of the truth with a convincing – photo proofed backed lie.

Every Sunday, I see them.

My grandparents' house in Dandenong, the smell of home. Southeast of Melbourne it is known for its amazing scenery and beautiful national park lands. A place of lush flora and fauna in Victoria.

Last Sunday was unique. We Always sit in the fifth row. At seven in the morning there is no fighting over seating really. Nana and papa sit at the window seat and I sit on the aisle. Yet, on the ninth of August 2023 someone was in my seat. Nana and papa's seats were free but my seat was not.

I asked politely if I could sit next to my grandparents to which the young man stared at me oddly. Raising his eyebrows puzzled, like I was delusional. I persisted and asked again, tilting my head to the side, gesturing towards my grandparents. His look unchanged, still blank. This time buckling his belt for comfort. His head turned forward and proceeded to ignore me. Upset, yet with a seat spare facing my papa I sat on the chair facing him. Papa started to get upset. I motioned to him not to stress over the boy. "I am still sitting next to you." I spoke. Tapping my papa's knee.

Suddenly, the boy who had stolen my seat smacked my hand from reaching papa. Shocked I stood up, so did the boy. Chapter Nine 'Truth VS Lies'

Be careful what lies you tell about me, some dick heads maybe corrected in these books. Defamation is costly. Perjury is a crime punishable by incarceration.

The truth about Truro, Sth AUS was I wasn't a safe as it seemed. My friends unsure if the old man was being seedy myself propositioned by patrons that he was looking for a new wife while another ex SAPOL cop's friend joked about a wedding Max encouraged as conversation, I don't know the truth behind the motivation to invite myself to lease a room. What I do know is. It went from a positive position of myself opening the pub with keys. Too being told Max was pissing out blood, and a negative turn when I started to settle in and trust the situation. Myself working 38 hours over the fortnight of residence, it seems the publican decided he'd lie to his family for God knows what reason or motivation. His ex-wife saying he had bitched and moaned about the last young lass he invited to rent a room also. The last girl seemingly liked by Max to me, by the time the month of May had passed, I knew not what to believe coming from these people's mouths of this small-town housing paedophiles and victims alike in the area. Paedophilia associated with Don Dunstone as I publicly disclosed SA Labors disgrace. Some in the pub spoke of SA Government

funding thar fuelled the area for decades. These actions were due to SAPOL criminal negligence - That I was sure of. SAPOL failing to charge Kurt Slaven in a timely manner not only causing reckless endangerment and an extraordinary emergency but also always exposing demographics involved in the sex industry and paedophilia. A work for rent arrangement which seen me work for more than I had to pay in rent, staff and locals referring to the place as old, run down and musty. Quickly the agreement turned into myself being accused of not paying my way, despite cash payments of at least dollars fifty per week over the bar, working the bar, cleaning the house, washing and waitressing. A point made about OnlyFans, which Max (Wilson) had been present in half a dozen conversations about and was under no illusion about the site and how I had used the website. It had been a couple of weeks and I worked both those weeks witnessed by locals and tourists alike. The defamation and the false allegations came maliciously from Max's daughter feeling very comfortable trying to make a person homeless despite a verbal tenancy trying to use family as an excuse, which is not a legal reason to terminate a lease. I chose not to argue despite just committing to three major investment projects (Television Commercials, Eco Fashion Week Australia and International Book Fairs – Frankfurt, Germany) with my brand Barbwire Noose decisions made based on Max promise of tenancy. Set to move to the United States with a Consulate Green Card Visa, I was not going to fuss over the residence. The defamation sure to spread the small town before the truth, I lay stunted over night at the prospect of another name to the defamation list of legal suits.

I had just seen Mad Max Furiosa movie at Salisbury Cinema with a guy I met working as bar waitress at the Truro Pub. A group of regular passers through pub staff said. It was weird, the staff thought these regulars were truckers, they were actually in the shearing industry. Max's daughter (Kristen) stating I should move in with this bloke I met in her dad's pub three days ago. WTF, a nice enough guy I was forced to find out yet not my type to build a life with or to reside with before going international regarding business and residency. The obnoxious comment made by Kristen after a tale about a bullshit family saga which was not my problem as she put to me about my lease agreement not being her problem. Her fathers' health wasn't my problem either yet I had spent time looking after him when the family weren't worried about his death bed and gaining from the pub's sale in his ill health. The whole picture looked like a mess to me. The only solution to these not fans of OnlyFans turned UGLY defamatory gossips was most likely a legal cease and desist demanding they stop discussing financial matters they have no founded knowledge of - mine. If you can't tell or see the truth, best not take defamation to the point where it is perjury. Leave me out of your financial gains, like you should stay out of mine I thought to myself as this shit went down. I had cooked my Nanna's traditional curry on this day, asked to cook this curry by Max, the ingredients I was sourcing after returning from a trip to Mount Gambier, Sth AUS where I should have stayed, I believe. Max was that keen on curry being cooked, he bought the ingredients and asked me to cook it the morning I was asked to vacate. Max had to have encouraged this behaviour from the background, desperate for money seeking a million dollars for his pub plus stock which no one believed the pub was worth. He had a desperate greed motivation and was friends with two excops who regularly visited the pub, one SAPOL and one

VICPOL. I felt sorry for him more than the resentment he deserved. "He'll die there" they would say, ill in health I positively supported his dream of a million dollars. The truth, he struggled to tie his shoelaces and life would probably see him die in coming times. Knowing what I knew, I politely cooked the curry, despite a day of lies and disrespect. The damages to my reputation guided by how much costs are incurred against my business and self as mid 2024 played out. The first incarceration tort occurred in my second week of my studies; studies effected by the move. I hoped for generosities sake the damages were short lived from this intentionally malicious decision of police malfeasance. The decision to try and make me homeless could have involved a two week notice at least to allow me to make other arrangements yet the family of Maxwell Wilson did not. No one can save a liar from there lies but them and after being told I hadn't paid my way when I had offered money, worked my RSA and waited food as well as looked after the pub when the publican got a urine infection which left me in charge of the pub all day. Which I worked numerous times over my stay by myself with no dramas. Myself emotionally distressed by the decision, feeling used and rightfully so. This sudden change of heart was rather unexpected, unwelcomed, and unwarranted (as well as illegal). The fact that it was a cover to try and collect one million dollars from the sale of an old pub not valued at much more than half of a million - which Maxwell achieved. says that this man and his family will attempt to steal justice from the most vulnerable in our society for money. Low choice.

Imagine for a moment that you were disabled - unable to move to push somebody away or feed yourself. Unable to

speak to say "no", "that food is too hot" or that you are "hungry". Yet you could 'feel' hungry, comprehend sound, shiver because you were cold. Close your eyes for a moment and really think about this reality.

This is the reality of four out of five clients (our peers), I cared for as a 'Disability Officer' employed by the South Australian (SA) Labor government, who lived at Sharley House, Mount Gambier during year 2004.

The organisation IDSC re branded too Disability SA and I (Marcia Anita Hobbs) reported the criminal negligence to management and the disability minister (at this time) – Jay Weatherill. This is 'The Story Behind the Brand – BARBWIRE NOOSE' CLOTHING. My human rights activism for the voiceless, for all of us started in year 2005. I am a lover, not a fighter. Yet for my disabled peers I have fought for their justice for over two decades. Taking up the government employment role in the disability sector in year 2003, I was pushed out of this sector in 2007. Reprisal for seeking justice - the right of our disabled peers to be recognised as people under the law; a Human Right. Article 6 states: Everyone shall have the right to recognition everywhere as a person before the law. A fight that inspired a brand, a movement, a chapter in both book and time which drove the registration of the trademarks 'Fear Is the Root Of All Weakness' and 'Barbwire Noose'.

Severe criminal negligence – Medical, nutritional, physical, sexual offences committed against mute unable to communicate (write, sign language, speak), fight, move away disabled peers. I was only 19 years of age when I took the position with IDSC as a disability officer. The Truth Matters. Human Rights Matter. This is 'The Story Behind the Brand – BARBWIRE NOOSE' CLOTHING, my story – their story, our story. A true account of no matter how big or

small, rich or poor, boy or girl - we can all be heroes and make A Better World.

In my 30s I could never have imagined advocating victims' rights, human rights including freedom of speech I'm fair trial with a global a publication, a submission to the Disability Royal Commission and incarceration record facing and character assassination designed to hide - oppress the truth.

An act of heroism as many have commented and complimented. I do not see myself as a hero. I see myself as a little girl - just over 5 feet tall, averaging approximately 50 kilograms - locked in protest fighting for Human Rights — the entitlement of an apology for the voiceless from the government regarding the malfeasance and crimes committed against their human lives.

I would like to think everyone would fight for disabled people, those weaker than you - our human rights. Unfortunately, this is a naive reality. The truth traumatic, weaponized, and ignored by government with authority assistance.

I kept an autobiographical (Political Prisoner #192703) account of my time spent in Adelaide Women's prison due to cover ups in government sectors. A battle, advocating and hoping to survive a moment in time, which seen my 'One Love' clothing brand debut its first television commercial promoting human rights broadcast on channel 9. I watched my clothing brands advertisement of its biographical book (The Story Behind the Brand) and Barbwire Nooses successes/establishment from the confinement of a prison cell. The book calling for an apology from the SA Labor government, led by Peter Malinauskas (2024) which he received at his Port Road office in October 2023. Peter Malinauskas (2024) ignoring the facts for over a year.

Autobiographies, a brand dedicated to 'A Better World' – Human Rights. The autobiographical series 'ANYTHING BUT ORDINARY – Judgement and Perception have NO Value Here' Books full of candid facts, experiences, quotes and open to interpretation depending on where the reader's head is at – judgement, education, my life and thoughts. Stories of the heart, mind and soul consisting of personal views, knowledge and life experiences as well as lighthearted, comedical references, poetry and more. Quoting a letter to Professor Fatima Meer from the book 'Conversations with Myself' by NELSON MANDELA: "The trouble, of course, is that most successful men are prone to some form of vanity. There comes a stage in their lives when they consider it permissible to be egotistic and to brag to the public at large about their unique achievements. What a sweet euphemism for self-praise the English language has evolved! Autobiography, they choose to call it, where the shortcomings of others are frequently exploited to highlight the praiseworthy accomplishments of the author." Reading this as a true crime's writer, an author of biographical literature; I could relate to Nelson Mandela's view of the autobiography. Though I have made sure my life's evolution in its imperfections and perfections, have been equally shared, I cannot help but feel at times the personalness of my autobiography's have truthfully and graphically shared shortcomings of others - not just my own. Being mindful not to brag yet proud of my achievements, this euphemism interpretation is bang on the realities of a biographical record. The highs and the lows of life, often shared moments. When the hunter talks of killing the lion, it is the hunter's life that is glorified, though the lion has great achievements of its own unshared as a hunter only knows his own life and the lion's role in it.

In approximately 2011, while my Mum worked at a café in the 'Centro' shopping complex of Mt Gambier, Sth AUS she pointed out an 'Anita' massage therapist advert in the newspaper – The Border Watch newspaper of Mt Gambier. My mother's name 'Anita' I thought the joke was regarding name and name. Mum and Dad worked for the same couple - husband and wife, both employers having businesses with their name in the business name. The café 'Ellen's Café'. I found Mum's boss Ellen to be over-bearing and rather unfriendly. This personality fit the description of her husband also whose personality seen my dad quit his job as a painter with the man. A demeaning and unfriendly couple as I experienced it. The truth of this moment was it was unforgettable, Mum laughing at presumably a sex worker with the same name as her own. Kinda odd, funny because it is odd. My mum and I with a strained relationship and this random moment making up much of the reasoning why I removed my middle name when I applied for my name change in 2021. Too much bullshit. Well over the malicious accusations with no basis, facts or evidence. My mother's insinuations, accusations and narcissism, coupled with poor judgement, etc very much behind my drive to disassociate from her name. The defamatory, untrue commentary she had indulged since I was employed under her leadership at Hungry Jack's in 2001 when she sided with a paedophile (Greg Phillips – Pastor) when I housed the stepdaughter he abused when we became friends through this employment was the start of something more than teenage rebellion and a rift.

Opportunists are everywhere – true but not noteworthy. What is noteworthy is the horde of 'new' friends I have acquired while police desperately ran a cover up of sex

crimes for themselves and the government. I've written much about 'Human Resources' used by police – compromising public safety in the name of 'law enforcement'. I've also called out some military associations with this agenda in the Comancheros. 2023, after the release of my brands publication, a horde of 'friends' reared their heads. New and old, yet nearly all of these so-called friends had Never been invited to one of my birthday parties. Why? Because personally I know them as acquaintances or barely at all, not friends. From work colleagues to fellow whistleblowers – Royal Commission submitters. Everyone had an agenda, namely defamatory, all inflammatory and most with a toxic benefit to talking to me. From Navy personnel I never knew before public disclosures – persons who are in coercive control relationships where children are subject to damaging domestic violence to persons taking payouts from the government in health sectors – many based-on perjury, false claims. None of these people though, these friends around for my birthdays – lucky if there was one between 2022 - 2024. Most of these people unable to tell you how I've spent/celebrated any of my birthdays without reading my books. So called friends who have not been a part of my life long enough to know jack shit about me. Fifteen minutes of fame for some, petty payouts for others, whatever the incentive – whatever they think is clever. Taking justice from our disabled peers meant nothing to some. The lows of such persons who call themselves my friends are the only real truths these people carry about me. Like sharing a cell with a compulsive liar with severe bipolar, schizophrenia – mind-blowing madness to claim friendship as a foe.

The bitter-sweet truth of two men, both wanting a relationship with myself. Both wanting a relationship with me ahead of my input into the matter, have tattoos dedicated to me. Most people have thought these unsolicited by me relationship seekers actions as odd. And a bit scary. One of these men in 2018 was investigated for stalking. The other becoming my friend during incarceration at AWP, maybe a stalker. All of my body art – tattoos are personally of a serious significance. I'm not sure if I am flattered or scared. I do genuinely hope the art of these men is seriously significant. Truth be told, I don't know how to feel about this activity – their body, their choice I suppose. I say the significance of these acts' spans to the level of my use or their ability to use the situation. Time is always a telling factor. The truth more often than not evident in the wash. one day, highly likely through the hope of a polygraph test.

The number of women I have met subject to malicious intervention orders after reporting domestic violence since 2018 is outstanding. Like the numbers of women who die at the hand of a significant other, the truth about intervention and domestic violence in Australia is the police forces fail to address the real issues early, self-defence (or death) becomes a victim's only option and prosecution then falls upon the victim instead of the offender. For these women death is inevitable, the rest is choice. Fight or flight with love blurring the line to choose immediate safety every time. Humans, emotive beings with our biggest flaw our ability to feel so deeply that our judgement is often overridden by emotions.

The truth be told, I am fascinated with flying and I do find the occupation of a pilot to be an attractive trait. 

Chapter Ten 'Freemasonry'

"A man cannot lay down the right of resisting them that assault him by force, to take away his life." - Thomas Hobbes, Leviathan.

Becoming a Freemason is a commitment to develop your own potential, to values that see all humankind as equal, and to helping others in our community. — SA/NT Freemasonry Australia.

In Australia, there are Grand Lodges on Castlereagh Street in Sydney, Albert Street in East Melbourne, Ann Street in Brisbane, Commercial Road in Port Adelaide, Adelaide Terrace in Perth, Sandy Bay Road in Hobart and Stokes St in Darwin.

James Boag, brewer

Captain Matthew Flinders, explorer

Charles Kingsford Smith, aviator

Frank Clune, author

Harry Melbourne, the inventor of the Freddo Frog.

Graham Kennedy, TV entertainer

The first Grand Lodge was the Grand Lodge of England, was founded on 24 June 1717 when four London Lodges met for a joint dinner, proclaiming themselves pre-eminent and assuming regulatory control over Freemasonry in England.

The popularity of Freemasonry was spreading internationally. Grand Lodges were formed in Ireland in 1725 and Scotland in 1736. By the 1730s Freemasonry had also been exported to the British Colonies in North America and after the American Revolution, Grand Lodges began to form in each of the American states.

Significant contributions to Victorian history involve Freemasons. In Australia freemasonry truly began when 21 influential men drew up a petition on 23 December 1839 to form a Masonic Lodge, to be called the Lodge of Australia Felix. Previously, Freemasonry was governed primarily by three constitutions, coming from the English, Scottish and Irish settlers to Australia.

Freemasonry has been in Australia since the First Fleet and has played a pivotal role in the growth and establishment of our state. The Foundation Stones of some of the most prominent and culturally significant buildings in Melbourne and beyond were placed by prominent Freemasons – the Melbourne Court House, Melbourne Hospital, the Princes Bridge and much more.

By the 1800s there were more than 100 Lodges all over Victoria. In 1883, the Grand Lodge of Victoria was established to oversee Freemasonry throughout Victoria. Formed in 1889, the United Grand Lodge of Victoria had its first Installation at Melbourne Town Hall with over 6000 Freemasons in attendance.

Freemasonry focuses on personal development and community contributions, so it is no surprise that many of

our most influential and notable citizens past and present are Masons. A history of Victoria's most prominent men is also, often, a history of prominent Masons. Among these are George Brunswick Smythe, namesake of Brunswick Street, and instigator of modern Freemasonry in Victoria, and William Meek, founding Secretary of the Melbourne Club, along with George Selth Coppin who was instrumental in the birth of the Melbourne Hospital and the Royal Freemasons Homes just to name three examples.

Community minded Masons have served in public office throughout Victoria's history – Victorian Governor Generals, Mayors (such as Charles Brunton, for whom Brunton Avenue is named), and Prime Ministers Sir Edmund Barton and Sir Robert Menzies.

Masons have also made their contributions in other areas too, even the sporting arena – Sir William Clarke, first Grand Master of the United Grand Lodge of Victoria was the man who is responsible for the cricket Ashes. In 1884, after visiting England and watching the Australian cricket team beat England for the first time, Sir William invited the entire English team to his residence in Sunbury. He proceeded to burn the bails from a stump and place them in a special ceramic urn which he then presented to the English team to mark the defeat, and so the Ashes were born. For over 125 years Freemasons in Victoria continue to play instrumental roles in the development of our state.

The shameful behaviour of the Adelaide Grand Lodge exposed that Freemasonry and Freemasons could no longer be trusted on the basis that members are moral and ethical within the religion. A religion kept secret by a veil of symbolism, seedy dealings turning the once superior religion

- an arm of Christianity, worship of God and understanding of the great architect of the universe into a veil of deceit overshadowing morals and ethics. Co-Freemasonry leading the way of true religious direction, the Grand Lodge of Adelaide, Australia had a lot of sex offending to hide within its instrumental role in building South Australia, Adelaide – the city of churches.
